The Greater Brighton Collie Club and the Toledo Collie Club and the Show Secretary, their agent, employees, etc. assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers or by any of their dogs or property and further assumes no responsibility for injury to children.

No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance, postdated and returned checks do not constitute a valid entry fee. The Show Secretary will add a \$30.00 fee to each returned check

No Refunds for duplicate entries. Every effort to find duplicate entries will be made. Owners will be responsible for errors in making out entry forms. Whoever may make such errors, and no entry fee will be refunded in the event of such errors or cancellations after the published closing date and time.

Judges will not wait for any dog holding up a class. Owners are responsible for the presence of their dogs in the judging ring when their classes are called. Dogs may arrive any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.

Cash prizes/trophies/awards will be given out in the ring to the person showing the dog. The Show Secretary, Toledo Collie Club, and Greater Brighton Collie Club disclaim any liability for cash prizes after the judging is over. All trophies/Awards will be awarded in the ring. No trophies/Awards will be mailed.

Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or judge or barred from competition by action of the Event Committee. If because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or complete the show, no refund will be made. Extreme Weather conditions, such as but not limited to storms, hurricanes, lightning, extreme heat must be considered for the health and safety of the exhibitors, dogs and spectators. The well-being of the dogs and spectators is of paramount importance and in the event, it is necessary to cancel or stop the show before completion, no refund of entry fees will be made.

These Clubs do not agree to the arbitration claims set forth on the official AKC entry form for these events.

Competition is needed for Best Junior Handler Award

AKC Junior Handler numbers are now required for entry in Junior Showmanship Competition. Numbers may be obtained from the AKC, Phone 919-816-3776 or email tbh@akc.org.

Entry Blank must be filled out with the necessary information, otherwise the entry in Junior Showmanship will not be accepted.

Classes Offered: Novice Junior, Novice Intermediate, Novice Senior, Open Junior, Open Intermediate, Open Senior, Master

Novice Class – For boys and girls who are at least 9yrs old and under 18yrs old on the day of the show and who, at the time entries close, have not won three First places, with competition present, in the novice class at a licensed or member show.

Open Class – For boys and girls who are at least 9yrs old and under 18yrs old on the day of the show and who, at the time entries close, have won three First places, with competition present, in the novice class at a licensed or member show.

Master Class - For boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

NOTICE

Juniors who substitute for the original dog they have entered in the Junior Showmanship Classes with a dog that is not entered in one of the offered classes at this show must remit the Junior Showmanship Only fee with their substitution.

BUILDING INFORMATION

The Show Site will be available Friday March 4, 2022 from 5pm to 10pm. Please stack all crates. This is a self-cleaning show. Owners, Agents or Handlers are **REQUIRED** to clean up after their dogs in all buildings and outside on the grounds. **NO ex-pens allowed inside buildings; NO Alcohol allowed on the premises.** Grooming and exhibiting located in the same building.

- Crates must be stacked if requested by the Event Committee.
- The use of Foul or Abusive language may result in a hearing of the Bench Committee.
- All Cellular phones and devices must be set to vibrate or turned off while in the building during judging.
- **NO SMOKING WILL BE ALLOWED INSIDE ANY BUILDING.**
- Spectators/Exhibitors are allowed to videotape dogs in the ring as long as it does not interfere with judging, the comfort of others exhibitors and/or obstruct the free flow of foot traffic. Flash photography of dogs while they are competing inside the show ring is not permitted.
- All persons attending this show waive any claim for damages against the Greater Brighton Collie Club (GBCC) or the Toledo Collie Club (TCC) or its members in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.

COVID RESTRICTIONS:

This show will adhere to AKC's suggested best practices for the well-being of the dog sport participants. These can be found on AKC's website.

State Requirements will be followed

- * Masks are required to be worn at all times when not at your car. Masks must be worn correctly in the ring, at all times to protect the judge & exhibitors.
- * Setups will be minimum of 6 feet apart from each other.
 - * Temperature checks will be completed & wristbands handed out prior to admittance to the grounds
 - * Completed COVID Waiver forms are required prior to grounds admittance.

From the East: Take I-75 to Exit 93, turn right at Dixie Hwy, and go 2 miles. Turn left onto Davisburg Rd. and drive 2.5 miles. Turn left on Andersonville Rd. The show site is on the right in 1/2 mile.

From the North: Take I-75 to Exit 98 E Holly Road. Turn right. Take 1st right onto Tindall Rd. Go .8 miles and turn left at Rattalee Lake Rd. Take 1st right onto Bigelow Rd. Go 1.5 miles. Turn Right on to Davisburg Rd. and travel 2.5 miles to Andersonville Road. Turn left onto Andersonville Rd. Event site will be on the right .8 miles.

From the West: Take I-69 N to Exit 98. Follow directions above from there.

From the South: Take US-23 N to Exit 78 - Owen Rd. Turn right and go 1.6 miles to S. Adelaide Street. Take 3rd left onto W. South Holly St. Road changes names 3 times (S. Holly Rd, Fenton Rd, and Milford Rd.) Turn left at Davisburg Rd. Drive 3.8 miles and turn right at Cross Hill. Take 1st right onto Andersonville Rd. Drive .7 miles to destination on the right.

The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
